EXECUTIVE ORDER NO. 8 Series of 2017

AN EXECUTIVE ORDER CREATING THE CITY INTER-AGENCY COUNCIL FOR RESPONSIBLE PARENTHOOD AND REPRODUCTIVE HEALTH

WHEREAS, Section 15 of the 1987 Constitution provides that "The State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, as a manifestation of its strong commitment to the Constitution, to basic human rights, gender equality and to the Reproductive Health and Responsible Parenthood (RPRH) Law, the City of Tabaco intends to localize a comprehensive implementation of Responsible and Reproductive Health within its jurisdiction;

WHEREAS, with the enactment of the Responsible Parenthood and Reproductive Health Law, reproductive health services will be carried through a structure under the City Government of Tabaco, which shall be the venue to share and maximize available resources, coordinate action to prevent duplication, ensure that responsible institutions assume responsibilities on activities not within the practice, increase participation to Responsible Parenthood and Reproductive Health mobilization for greater impact and ensuring continuity of RPRH efforts by the institutions in the City of Tabaco;

WHEREAS, the creation, organization and performance of functions of the City Inter-Agency Council for Responsible Parenthood is guided by the provisions of Albay Provincial Ordinance No. 0016-2016, an ordinance establishing the Albay Inter-Agency Council for Responsible Parenthood and Reproductive Health, defining its functions and composition;

NOW THEREFORE, I, CIELO KRISSEL LAGMAN-LUISTRO, City Mayor of Tabaco City by virtue of the power vested in me by law, do hereby ordain the following:

SECTION 1. ORGANIZATION AND COMPOSITION OF THE CITY INTER-AGENCY COUNCIL FOR RESPONSIBLE PARENTHOOD AND REPRODUCTIVE HEALTH. The City Inter-Agency Council for Responsible Parenthood and Reproductive Health is organized and shall be composed of the following.
