The *City Government of Tabaco*, through its *Trust Fund 2018 (Reprogrammed Calamity)* to apply the sum of *Nine Million Two Hundred Seventy-Six Thousand Two Hundred Fifty Pesos (Php9,276,250.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *Supply & Delivery of Brand New Wheel Excavator, CDRRMO, Tabaco City under Contract ID No. 029-09-2018-GOODS*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *City Government of Tabaco* through the Bids and Awards Committee (BAC) now invites bids for the *Supply & Delivery of One Unit Brand New Wheel Excavator (see description below)*. Delivery of the Goods is required within *ninety (90) days from receipt of Notice to Proceed*. Bidders should have completed within *three years* from the date of submission and receipt of bids a similar contract with an amount of at least 50% of the Project to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

5. The BAC will hold a pre-bid conference on **October 09, 2018, 2:00 PM** at the BAC Conference Room, 2F Annex Bldg., City Hall, Tabaco City, which shall be open only to all interested bidders who purchased the Bidding Documents.
6. Bids must be delivered to the address below on or before **October 23, 2018, 9:00 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **October 09, 2018, 9:30 AM, BAC Conference Room, Mezz. Flr., City Legal Office, 2F Annex Building, City Hall, Tabaco City**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
