INVITATION TO BID For the Supply& Delivery of Grocery Items Packed in Customized Gift Boxes Contract ID No. 030-10-2018-GOODS ABC: Php 8,705,920.00

- 1. The City Government of Tabaco, through its General Fund 2018 intends to apply the sum of Eight Million Seven Hundred Five Thousand Nine Hundred Twenty Pesos (Php 8,705,920.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply & Delivery of Grocery Items Packed in 34,000 Customized Gift Boxes at the City Mayor Office, Tabaco City under Contract ID No. 030-10-2018-GOODS. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The City Government of Tabaco through the Bids and Awards Committee (BAC) now invites bids for the Supply & Delivery of Grocery Items Packed in 34,000 Customized Gift Boxes (see description below). Delivery of the Goods is required within thirty (30)calendar days from receipt of Notice to Proceed. Bidders should have completed within three years from the date of submission and receipt of bids a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Interested bidders may obtain further information from the Bids and Awards Committee (BAC) through its Secretariat and inspect the Bidding Documents at the address given below from 9:00 AM-4:00PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on *October 15-November 05*, 2018 from 9:00 AM to 4:00PM from the address below upon submission of Letter of Intent (LOI) to participate and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Ten Thousand Pesos (Php10,000.00)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The BAC will hold a pre-bid conference on *October 25,2018, 9:30 AM*. at the BAC Office, 2F Annex Bldg., City Hall, Tabaco City, which shall be open to prospective bidders.
- 7. Bids must be received by the BAC Secretariat at the address below on or before *November 06*, *2018*, *9:30* A.M. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on *November 06, 2018, 9:30 A.M.* at *BAC Conference Room, Mezz. Flr., City Legal Office, 2F Annex Building, City Hall, Tabaco City*. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
