A RESOLUTION DECLARING THE SECOND FAILURE OF BIDDING FOR THE SUPPLY OF LABOR, MATERIALS AND EQUIPMENT FOR THE CONSTRUCTION OF WASTEWATER TREATMENT FACILITY AT SLAUGHTERHOUSE, SAN CARLOS, TABACO CITY UNDER CONTRACT ID NO. 018-11-2020-INFRA

WHEREAS, the City Government of Tabaco has posted the Invitation to Bid for the Supply of Labor, Materials and Equipment for the Construction of Wastewater Treatment Facility, Slaughterhouse, San Carlos, Tabaco City (Rebid) under Contract ID No. 018-11-2020-INFRA with an Approved Budget for the Contract (ABC) amounting to Php 4,993,736.79 in the PhilGEPS and Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to said posting, one (1) prospective bidder has shown interest to participate by purchasing the bidding documents and subsequently submitting its bid before the deadline for submission of bids on January 18, 2021;

WHEREAS, the opening and preliminary examination of bid resulted as follows, to wit:

WHEREAS, on January 19, 2021 the BAC conducted the detailed evaluation of bid which resulted as follows, to wit:

WHEREAS, however, upon conduct of post-qualification of Pure Green Solution Technology, Inc. on January 20-February 01, 2021, involving careful examination, verification, validation and ascertainment of all statements and representations made in relation to its bid, it was found to be non-compliant and non-responsive to the requirements and conditions of the project on the following grounds, to wit:

Mayor's or Business permit issued by the city or municipality where the principal place of business of the prospective bidder is located, or the equivalent document for Exclusive Economic Zones or Areas	The submitted Mayor's Permit was expired on December 31, 2020 and no Official Receipt as proof of Renewal was submitted together with the expired Mayor's Permit.		
List of contractor's key personnel (e.g., Project Manager, Project Engineers, Materials Engineers, and Foremen), to be assigned to the contract to be bid, with their complete qualification and experience data;	The supporting documents for the qualification and experience data of key personnel to be assigned to the contract to be bid were not complete, e.g. valid PRC Licenses, Training Certificates and relevant experiences in their Bio-Data		
Original of duly signed and accomplished Financial Bid Form	The bid form was not compliant in substance. Several statements in the prescribed form were omitted		
Cash Flow by Quarter	The period of cash flow by quarter is 150 calendar days which is beyond the 120 calendar days contract period.		

WHEREAS, based on the foregoing, the BAC declared Pure Green Solution Technology, Inc. as post-disqualified through BAC Resolution No. 2021-1Q-02-0007 dated February 02, 2021 and subsequently issued the corresponding Notice of Post-Disqualification on February 10, 2021, which was sent thru e-mail and LCB Express;

WHEREAS, the LBC Express has notified the BAC through a text message that the Notice was received by the bidder's representative on February 12, 2021;

WHEREAS, Pure Green Solution Technology, Inc. was given three (3) calendar days from receipt of the notice or until February 15, 2021 to file a request for reconsideration, if any;

WHEREAS, to date, the BAC has not received any request for reconsideration from Pure Green Solution Technology, Inc., which is construed as its waiver of its right to file a motion for reconsideration;

WHEREAS, Section 35.1(c) of the 2016 Revised IRR-RA9184 provides that the BAC shall declare failure of bidding when all bids fail to comply with all the bid requirements or fail post-qualification;

NOW THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED, to declare SECOND FAILURE OF BIDDING for the Supply of Labor, Materials and Equipment for the Construction of Wastewater Treatment Facility, Slaughterhouse, San Carlos, Tabaco City under Contract ID No. 018-11-2020-INFRA.
