

# CONTRACT AGREEMENT

## NEGOTIATED PROCUREMENT FOR THE PUBLICATION OF CITY ORDINANCE NO. 074-2022


THIS AGREEMENT, made this DEC 01 2022 2022 between the **CITY GOVERNMENT OF TABACO, Tabaco City, Albay, Philippines** (hereinafter called "the Entity") of the one part and **THE BICOL REGIONAL WEEKLY DIGEST, 3/F Rivera Building, Rizal St., Legazpi City** (hereinafter called "the Supplier") of the other part;


WHEREAS, the Entity invited Bid, for certain goods and ancillary services, particularly **Publication of Various City Ordinance (Ordinance Nos. 075-2022; 079-2022; 8-002, series 2022; 8-003, series 2022)** under RFQ No. 1330-2022 and has accepted a Bid by the Supplier of goods and services in the sum of **One Million One Hundred Eighteen Thousand Two Hundred Seventy-Five Pesos and Twenty Centavos (Php 1,118,275.20)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Request for Quotations (RFQ)
    - a. Terms and Conditions
    - b. Supplemental Bid Bulletin, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Price Quotation, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the RFQ. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **One Million One Hundred Eighteen Thousand Two Hundred Seventy-Five Pesos and Twenty Centavos (Php 1,118,275.20)** or such other sums as may be ascertained, **THE BICOL REGIONAL WEEKLY DIGEST** agrees to the **Publication of Various City Ordinance (Ordinance Nos. 075-2022; 079-2022; 8-002, series 2022; 8-003, series 2022)** in accordance with his/her/its Bid.
4. The **City Government of Tabaco** agrees to pay the above-mentioned sum in accordance with the terms of the Contract.




