A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO COTTON CITY MARKETING FOR THE SUPPLY & DELIVERY OF VARIOUS PPE'S FOR MAINTENANCE SECTION PERSONNEL-ISLAND AND MAINLAND

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1416** with an Approved Budget for the Contract (ABC) of **Php 142,203.00**;
