A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KING JAMES ENTERPRISES FOR THE SUPPLY & DELIVERY OF HARDWARE SUPPLIES FOR THE 1 UNIT FLOATING COTTAGE AND FABRICATION OF ANCHOR MADE OF CEMENT

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1426** with an Approved Budget for the Contract (ABC) of **Php 74,797.00**;
