A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JRE AGRIVET SUPPLY FOR THE SUPPLY & DELIVERY OF ANIMAL VITAMINS FOR TREATMENT AND SUPPLEMENTATION OF FARM ANIMALS

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:




