A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO LIFERICH CONSOLIDATED CORPORATION FOR THE MEALS & VENUE FOR THE EMPOWERING WOMEN IN THE ECONOMIC ENTERPRISES
