A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MMC MARKETING FOR THE SUPPLY & DELIVERY OF ELECTRICAL SUPPLIES FOR THE REPAIR AND MAINTENANCE OF FEEDER LINE AT BRGY. ANGAS SAN MIGUEL ISLAND, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1444** with an Approved Budget for the Contract (ABC) of **Php 229,000.00**;
