A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ENVIRO SCOPE SYNERGY INC. FOR THE SUPPLY & DELIVERY OF ORGANIC PLANT SUPPLEMENT TO BE DISTRIBUTED TO VEGETABLE FARMERS
