A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KRMKA GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF BATH TOWEL, TUMBLER AND, UMBRELLA TO BE GIVEN AS TOKEN FOR NUTRITION ASSESSMENT PROGRAM 2022

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1467** with an Approved Budget for the Contract (ABC) of **Php 129,465.00**;
