A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MANJARES ENTERPRISES FOR THE SUPPLY & DELIVERY OF SEEDS FOR TREE PLANTING ALONG THE PERIMETER OF SAN VICENTE AND SAN ANTONIO CLOSED DUMPSITE
