**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO B & C ELECTROMECH FOR THE SUPPLY & DELIVERY OF VEHICLE PARTS FOR THE MAINTENANCE OF SERVICE VEHICLE OF SP/VMO**

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1550** with an Approved Budget for the Contract (ABC) of **Php 63,500.00**;
