A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO TCL MERCHANDISE BROKERAGE INC. FOR THE SUPPLY & DELIVERY OF ELECTRIC OVEN FOR THE BREAD AND PASTRY PRODUCTION TRAINING ECONOMICALLY DISPLACED WOMEN FOR LIVELIHOOD TRAINING

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1558** with an Approved Budget for the Contract (ABC) of **Php 100,000.00**;
