A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO SAN CARLOS HARDWARE OPC FOR THE SUPPLY & DELIVERY OF CONSTRUCTION MATERIALS AND SUPPLIES FOR THE REHABILITATION OF SAN VICENTE RICEMILL, BRGY. SAN VICENTE, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1588** with an Approved Budget for the Contract (ABC) of **Php 598,157.00**;
