A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CASA VER AMORE INC. FOR THE MEALS AND VENUE FOR THE ADVOCACY FORUM ON PWAD RELATED LAWS AND OBSERVANCE OF THE INTERNATIONAL DAY FOR PERSON'S WITH DISABILITIES
