A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO POWER PRIME CAR SERVICE CENTER FOR THE SUPPLY & DELIVERY OF VEHICLE TIRE FOR CDU-830 OF GSO AND OY-9024 OF CDU/CDRRMO
