A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO PATIO DE SAN JOSE RESORT & CONVENTION CENTER INC. FOR THE HOTEL ACCOMMODATION, MEALS & VENUE FOR THE SKILLS ENHANCEMENT TRAINING FOR BARANGAY NUTRITION COMMITTEE MEMBERS (BNAP FORMULATION WORKSHOP)

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1612** with an Approved Budget for the Contract (ABC) of **Php 243,650.00**;


