#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO LIFERICH CONSOLIDATED CORPORATION FOR THE MEALS & VENUE FOR THE TEEN CENTER: TEENS EQUIPPED WITH SKILLS ENABLING THEM TO OPERATE THE TEEN CENTER
