**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ELRESPONDE SAFETY GEARS TRADING FOR THE SUPPLY & DELIVERY OF CADAVER BAG AND DISPOSABLE MASK**
