#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DISTRICT MUSIC CAFÉ DINER AND CATERING SERVICES FOR THE MEALS FOR THE RAPID DAMAGE ASSESSMENT AND NEEDS ANALYSIS

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1438** with an Approved Budget for the Contract (ABC) of **Php 84,000.00**;
