#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DISTRICT MUSIC CAFÉ DINER AND CATERING SERVICES FOR THE MEALS FOR THE TRAINING COURSE ON PUBLIC SERVICE CONTINUITY PLANNING

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1439** with an Approved Budget for the Contract (ABC) of **Php 98,000.00**;
