**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO UNIVERSAL COMMERCIAL CORP. FOR THE JO-LABOR & MATERIALS FOR THE REPAIR AND REPLACEMENT OF PARTS AND COMPONENTS OF TRUCK SCALE WITH INSTALLATION AND CALIBRATION**

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Direct Contracting under Section 50** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1454** with an Approved Budget for the Contract (ABC) of **Php 595,215.00**;

**WHEREAS**, the BAC has directly negotiated the foregoing procurement to **UNIVERSAL COMMERCIAL CORP.** by requesting the same to submit a price quotation or a pro-forma invoice together with the terms and condition of the sale;

**WHEREAS**, after the deadline for submission of price quotation, **UNIVERSAL COMMERCIAL CORP.** has offered to supply and deliver the goods at a contract price of **Php 595,215.00**;

**WHEREAS**, upon careful examination, validation and verification of all the documents submitted by **UNIVERSAL COMMERCIAL CORP.** the BAC found that it is technically, legally and financially capable to deliver the goods and the price offered is the most advantageous price for the government;

**NOW, THEREFORE**, in the light of the foregoing considerations, we the members of the Bids and Award Committee, hereby **RESOLVE**, as it is hereby **RESOLVED** to recommend for approval by the City Mayor, **CIELO KRISSEL LAGMAN-LUISTRO**, the award of the foregoing contract to **UNIVERSAL COMMERCIAL CORP.** at a contract price amounting to **Php 595,215.00**.
