**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JADIEM SCHOOL & OFFICE SUPPLIES DEPOT FOR THE SUPPLY & DELIVERY OF OFFICE AND OTHER SUPPLIES**

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1461** with an Approved Budget for the Contract (ABC) of **Php 53,398.00**;

**WHEREAS**, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

**WHEREAS**, after the deadline for submission of price quotations, the BAC received four (4) price quotations from suppliers, namely Legazpi General Merchandise, Jadiem School and Office Supplies Depot, R.A.B. Office Supplies & Equipment Trading, & Magic 8 Enterprise;

**WHEREAS**, the opening of price quotations resulted as follows:

**WHEREAS**, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, Legazpi General Merchandise was found to be non-compliant for failure to indicate the specific brand of all the items offered. Hence, its bid was also disqualified.

**WHEREAS**, the BAC proceeded with the examination, validation, and verification of all the documents submitted by the supplier with the second lowest quoted price, Jadiem School and Office Supplies Depot, and it was found to be responsive with the requirements of the project.

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To award the contract to **JADIEM SCHOOL & OFFICE SUPPLIES DEPOT** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
- b) To recommend to the City Mayor of Tabaco the award of contract to **JADIEM SCHOOL & OFFICE SUPPLIES DEPOT** in the amount of **Forty-Nine Thousand One Hundred Fifty-Six Pesos (Php 49,156.00)**.
