A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO M. BARSAGA EATERY FOR THE MEALS FOR THE KABATAAN SAFE SPACE: CONFRONTING CURRENT HEALTH ISSUES AFFECTING THE YOUTH

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1575** with an Approved Budget for the Contract (ABC) of **Php 58,000.00**;
