A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GENERAL MERCHANDISE INC. FOR THE SUPPLY & DELIVERY OF VARIOUS VEHICLE PARTS AND ACCESSORIES FOR THE REPAIR AND MAINTENANCE OF JM-4520 OF CEO, SGK-298 OF ANTI-SQUATTING UNIT, SAA-3742 OF CENRO AND BACKHOE WHEEL TYPE OF GSO

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1607** with an Approved Budget for the Contract (ABC) of **Php 90,063.10**;
