A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES & GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF DRUGS & MEDICINES FOR OB, HYPERTENSIVE PATIENT AND OUTPATIENT USE

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 23-02-0026** with an Approved Budget for the Contract (ABC) of **Php226,949.00**;
