A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO COTTON CITY MARKETING CORP. FOR THE SUPPLY & DELIVERY OF PERSONALIZED T-SHIRT WITH PRINT FOR THE TABAK FESTIVAL 2023 AND CITYHOOD ANNIVERSARY
