A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FACADE HOTEL FOR THE MEALS & VENUE FOR THE PUBLIC AWARENESS CAMPAIGN, POPULARIZE THE MRC, CASE REFERRAL SERVICES AND CLIENT SERVICES, HIGHLIGHT VAW, TRAFFICKING, ILLEGAL RECRUITMENT AND GENDER ISSUES AND CHANGING ATTITUDES TOWARDS WOMEN OFW'S.

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-03-0146** with an Approved Budget for the Contract (ABC) of **Php 69,900.00**
