A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF VARIOUS VEHICLE PARTS AND ACCESSORIES FOR THE REPAIR AND MAINTENANCE OF VEHICLE AND HEAVY EQUIPMENT WITH PLATE NO. D2C-830, SJX-677, JOB-874 AND MOTORPOOL SUPPLIES

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-03-0125** with an Approved Budget for the Contract (ABC) of **Php 63,557.60**
