A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JYQ ENTERPRISES FOR THE JO-LABOR & MATERIALS FOR THE REPAIR OF FEUGO VAN WITH PLATE NO. SGA-421 OF CDU/CITY DISASTER RISK REDUCTION MANAGEMENT OFFICE (CDRRMO)

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-03-0126** with an Approved Budget for the Contract (ABC) of **Php 73,116.00**
