A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MMC MARKETING FOR THE SUPPLY & DELIVERY OF HARDWARE SUPPLIES FOR THE REPAIR AND MAINTENANCE OF WATER UTILITY SYSTEM AT BRGY. SAN VICENTE, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-03-0170** with an Approved Budget for the Contract (ABC) of **Php 125,500.00**
