BAC Resolution No. 2023-2Q-04- 0229

A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO RRS MARKETING FOR THE SUPPLY & DELIVERY OF 2 UNIT AIR-CONDITIONING

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-03-0266** with an Approved Budget for the Contract (ABC) of **Php 150,000.00**

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the BAC received four (4) price quotations from suppliers, namely Refrik Aire Engineering, RRS Marketing, Willy & Sons Corporation, & Consumers Appliance Traders;

WHEREAS, the opening of price quotations resulted as follows:

WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, Refrik Aire Engineering was found to be non-compliant with the requirements of the project. The canvass form was not accurately filled in and if the installation cost will be considered and applied to its original bid offer, the quoted price will exceed the budget per item. Also, the COD term offered by the bidder non-compliant with the terms and condition of the project. With these findings, Refrik Aire Engineering was disqualified.

WHEREAS, the BAC proceeded with the examination, validation, and verification of all the documents submitted by the supplier with the second lowest quoted price, RRS Marketing, and it was found to be responsive with the requirements of the project.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To award the contract to **RRS Marketing** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
- b.) To recommend to the City Mayor of Tabaco the award of contract to **RRS Marketing** in the amount of **One Hundred Forty One Thousand One Hundred Pesos [Php 141,100.00]**
