A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES AND GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF DRUGS & MEDICINES, FATIMA WELLNES K-LINIK, TABACO CITY UNDER CONTRACT ID NO. 016-05-2023-GOODS

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Drugs & Medicines, Fatima Wellness K-linik, Tabaco City under Contract ID No. 016-05-2023-GOODS*, with an Approved Budget for the Contract (ABC) amounting to *Five Hundred Forty-Eight Thousand Three Hundred Two Pesos and Twenty Centavos (Php 548,302.20)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bid on June 09, 2023, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bid, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:







- a) To declare the bid of *MGM MEDICAL SUPPLIES AND GENERAL MERCHANDISE* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Drugs & Medicines, Fatima Wellness K-linik, Tabaco City under Contract ID No. 016-05-2023-GOODS*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *MGM MEDICAL SUPPLIES AND GENERAL MERCHANDISE* in the amount of *Five Hundred Twenty-Eight Thousand Three Hundred Forty-Four Pesos and Thirty Centavos (Php 528,344.30)*.




