**A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO NUTRIDENSE FOOD MANUFACTURING CORP. FOR THE SUPPLY & DELIVERY OF COMPLEMENTARY FOODS (RIMO BLEND & CURLS FOR FEEDING SUPPLEMENTATION OF 6-23 MONTHS OLD CHILDREN), CITY NUTRITION OFFICE, TABACO CITY UNDER CONTRACT ID NO. 022-07-2023-GOODS**

**WHEREAS**, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Complementary Foods (RIMO Blend & Curls for Feeding Supplementation of 6-23 Months Old Children), City Nutrition Office, Tabaco City under Contract ID No. 022-07-2023-GOODS*, with an Approved Budget for the Contract (ABC) amounting to *Five Million One Hundred Thirty Thousand Nine Hundred Forty Pesos (Php 5,130,940.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

**WHEREAS**, in response to the said posting, one (1) supplier has shown interest to participate by purchasing the bidding documents;

**WHEREAS**, during the deadline for submission and opening of bids on July 31, 2023, the BAC received one (1) bid proposal;

**WHEREAS**, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:



- b) To recommend to the City Mayor of Tabaco the award of contract to **NUTRIDENSE FOOD MANUFACTURING CORP.** in the amount of **Five Million Ninety Thousand Twelve Pesos (Php 5,090,012.00).**




