A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO 4KMB GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF MILK FOR SENIOR CITIZENS AND UNDERNOURISHED PRE-SCHOOL CHILDREN, CITY NUTRITION OFFICE, TABACO CITY UNDER CONTRACT ID NO. 023-07-2023-GOODS

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Milk for Senior Citizens and Undernourished Pre-School Children, City Nutrition Office, Tabaco City under Contract ID No. 023-07-2023-GOODS*, with an Approved Budget for the Contract (ABC) amounting to *Two Million Thirteen Thousand Fifty-Five Pesos (Php 2,013,055.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier has shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on July 31, 2023, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:







- To recommend to the City Mayor of Tabaco the award of contract to **4KMB GENERAL MERCHANDISE** in the amount of *Two Million Eighty-Eight Thousand Seven Hundred Fifty-Three Pesos and Seventy-Five Centavos (Php 2,088,753.75)*.




