A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO PIXEL8 WEB SOLUTIONS & CONSULTANCY INC. FOR THE SUPPLY & DELIVERY OF I.T. EQUIPMENT (DESKTOP COMPUTERS AND LAPTOPS), GSO, TABACO CITY UNDER CONTRACT ID NO. 027-07-2023-GOODS

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of I.T. Equipment (Desktop Computers and Laptops), GSO, Tabaco City under Contract ID No. 027-07-2023-GOODS*, with an Approved Budget for the Contract (ABC) amounting to *Eight Hundred Five Thousand Two Hundred Twenty-Five Pesos (Php 805,225.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier has shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on July 27, 2023, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:





- b) To recommend to the City Mayor of Tabaco the award of contract to *PIXEL8 WEB SOLUTIONS AND CONSULTANCY INC.* in the amount of *Seven Hundred Forty-Nine Thousand Six Hundred Four Pesos (Php 749,604.00)*.




