BAC Resolution No. 2023-3Q-09- 0959

A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO SERVE DIAGNOSTICA INC. FOR THE SUPPLY & DELIVERY OF HEMATOLOGY ANALYZER, CITY HEALTH UNIT, TABACO CITY UNDER CONTRACT ID NO. 030-08-2023-GOODS

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Hematology Analyzer, City Health Unit, Tabaco City under Contract ID No. 030-08-2023-GOODS*, with an Approved Budget for the Contract (ABC) amounting to *Six Hundred Eighty-Four Thousand Pesos (Php 684,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, two (2) supplier have shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on August 10, 2023, the BAC received two (2) bid proposal, namely Serve Diagnostica, Inc. and Quicklink Consumer goods Trading;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

The bid of Quicklink Consumer Goods Trading was rated Failed and automatically rejected during the opening of technical component for its failure to comply with the sealing requirement of bids.

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:

Serve was rated “Failed” for failure to sufficiently indicate in the Bid Form the mandatory provision on the taxes applied to its Bid Price. The provision “*The Total bid price includes the cost of all taxes, such as, but not limited to value added tax, income tax, local taxes, and other fiscal levies and duties, which are itemized herein or in the Price Schedules*” is among the mandatory provisions to be indicated in the Bid Form. Failure to include the same is a ground for disqualification (GPPB Circular No. 04-2020, September 16, 2020).

WHEREAS, the BAC has notified *Serve Diagnostica Inc.* of its disqualification on August 16, 2023;

WHEREAS, a Motion for Reconsideration was submitted by *Serve Diagnostica Inc.* on August 17, 2023 which was granted by the BAC as per BAC Resolution No. 2023-3Q-08-0924 dated August 24, 2023. In the same Resolution *Serve Diagnostica Inc.* was declared as the Single Calculated Bid and its bid was accepted for post-qualification;


WHEREAS, upon post-qualification conducted by the BAC Technical Working Group (TWG) involving the verification and validation of legal, technical and financial documents of the bidder with lowest


calculated bid, *Serve Diagnostica Inc.* was found to be substantially compliant with the requirements of the said procurement and its bid has been found to be responsive;

NOW THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a) To declare the bid of *Serve Diagnostica Inc.* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Hematology Analyzer, City Health Unit, Tabaco City under Contract ID No. 030-08-2023-GOODS*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *Serve Diagnostica Inc.* in the amount of *Six Hundred Eighty Thousand Pesos (Php 680,000.00)*.




