A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO TOPCARS AUTOWORLD CORP. FOR THE SUPPLY & DELIVERY OF BRAND NEW MONITORING VEHICLE FOR EMERGENCY AND DISASTER OPERATION, CDRRMO, TABACO CITY UNDER CONTRACT ID NO. 018-06-2023-GOODS-R1

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Brand New Monitoring Vehicle for Emergency and Disaster Operation, CDRRMO, Tabaco City under Contract ID No. 018-06-2023-GOODS-R1*, with an Approved Budget for the Contract (ABC) amounting to *One Million Two Hundred Thousand Pesos (Php 1,200,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on July 31, 2023, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:


