A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF VEHICLE PARTS AND ACCESSORIES FOR THE REPAIR AND MAINTENANCE OF VEHICLES WITH PLATE NO. SGZ- 495, SKE-759, BACKHOE LONKING AND PATROL BOAT
