A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JS ZAMORA CONSTRUCTION FOR THE JO-LABOR & MATERIALS FOR THE CONSTRUCTION OF DRAINAGE SYSTEM FOR FLOOD PREVENTION AT TCCT COMPOUND AT PAWA, TABACO CITY
