A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR FOR THE SUPPLY & DELIVERY OF LAPTOP FOR LGU INTEGRATED FINANCIAL TOOLS (LIFT) SYSTEM
