**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CASA VER AMORE INC. FOR THE MEALS & VENUE FOR 3 DAYS REFRESHER COURSE ON DOH PROGRAMS, PROJECTS AND ACTIVITIES**

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-04-0345** with an Approved Budget for the Contract (ABC) of **Php 142,800.00**
