A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DISTRICT MUSIC CAFÉ DINNER AND CATERING SERVICES FOR THE MEALS OF PERSONNEL WHO WILL ASSIST IN THE ROSTER OF ACTIVITIES OF TABAK FEST 2023
