BAC Resolution No. 2023-3Q-09- 1054

A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR FOR THE SUPPLY & DELIVERY OF IT EQUIPMENT (DESKTOP COMPUTER SET) FOR VARIOUS OFFICES, GSO, TABACO CITY UNDER CONTRACT ID NO. 035-08-2023-GOODS

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of IT Equipment (Desktop Computer Set) for Various Offices, GSO, Tabaco City under Contract ID No. 035-08-2023-GOODS*, with an Approved Budget for the Contract (ABC) amounting to **One Million Eight Hundred Thirty-Four Thousand Nine Hundred Fifty Pesos (Php 1,834,950.00)** in the PhilGEP website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, two (2) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on September 11, 2023 the BAC received two (2) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:


WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *Albay Computer & Electronics Supplies & Repair*, the bidder with the lowest calculated bid, which involves the verification and validation of its legal, technical and financial documents. It was found that *Albay Computer & Electronics Supplies & Repair* is substantially compliant with the requirements of the foregoing procurement project and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *Albay Computer & Electronics Supplies & Repair* as the Lowest Calculated Responsive Bid (LCRB) for the *Supply & Delivery of IT Equipment (Desktop Computer Set) for Various Offices, GSO, Tabaco City under Contract ID No. 035-08-2023-GOODS*; and


- b) To recommend to the City Mayor of Tabaco the award of contract to *Albay Computer & Electronics Supplies & Repair* in the amount of *One Million Two Hundred Seventy-Eight Thousand Six Hundred Ninety Pesos (Php 1,278,690.00)*.




