A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MMC MARKETING FOR THE SUPPLY & DELIVERY OF CONSTRUCTION MATERIALS AND SUPPLIES FOR THE REHABILITATION/IMPROVEMENT OF DRAINAGE AT BASUD ELEMENTARY SCHOOL, TABACO CITY
