A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BICOL SEEDS GROWERS MULTI-PURPOSE COOPERATIVE FOR THE SUPPLY & DELIVERY OF PALAY SEEDS TO BE DISTRIBUTED TO THE RICE FARMERS

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-04-0317** with an Approved Budget for the Contract (ABC) of **Php 309,600.00**
