A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ARIM ALBAY ENTERPRISES FOR THE JO-SUPPLY AND INSTALLATION OF 8KW SOLAR HYBRID SOLAR POWER SYSTEM AT MOTHER K-LINIK AT BRGY. SAN ANTONIO, TABACO CITY
