**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF VARIOUS VEHICLE PARTS FOR FUEL AND OIL FILTER FOR VARIOUS VEHICLE OF THE CITY GOVERNMENT OF TABACO**
